Nationally recognized presenter Alexis Artwohl, Ph.D., co-author of *Deadly Force Encounters*, presents an intense one day program that will provide the latest information on extreme stress incidents. The implications for training and conducting solid use of force investigations are enormous for the organization, the officer and for maintaining community trust.

Officers involved in these incidents often experience challenges to their perceptions, memories, and decisions. The incidents often take on their own complex dynamics involving officers and offenders, officers and other officers, agency stress, and can involve the community and their response depending on the incident.

While this course is too good to miss for any tactically minded officer, those investigating, managing, or training others, will find this information key to preparing the officer, agency, and trainers for these types of incidents.

Topics will include:

- Anticipating the common perceptual and memory recall problems of officers and witnesses;
- Procedural considerations supportive of "getting at" the truth;
- Recommendations to maximize officer learning;
- Biological, legal, and psychological aspects of extreme stress
- Understanding the medical necessities of extreme stress
- What happens when someone is shot?
- Common community concerns that arise.

Throughout this program interactive lecture/discussion will focus on case study review. Ample time is provided for input and questions from those attending.

The instructor for this course will be **Dr. Alexis Artwohl**, an internationally recognized behavioral science consultant. She serves on the National Advisory Boards of the Force Science Research Center and the International Law Enforcement Educators and Trainers Association. She is the Behavioral Sciences Section Chair for the National Tactical Officers Association. Areas of expertise include extreme stress events, the psychology of surviving deadly force encounters and coping with the aftermath and psychological issues relevant to investigating officer-involved shootings. co-author of the book, *Deadly Force Encounters*. She has written for *FBI Law Enforcement Bulletin*, Law Enforcement Executive Forum, and published numerous articles on officer involved shootings and use of force..
