



## CALEA's Response to President Biden's Executive Order to Advance Effective, Accountable Policing and Strengthen Public Safety

**Later today,** President Biden plans to sign an Executive Order aimed at putting new limits on federal law enforcement. According to the White House, the President's Executive Order will "enhance public trust by promoting accountability, transparency, and the principles of equality and dignity in policing and the larger criminal justice system."

For more than four decades, the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA®) has written, revised, updated, and promulgated standards developed for public safety agencies to use as a foundation and guide to ensure accountability and transparency, as well as equality and dignity within their ranks and the communities they serve. CALEA® maintains an organizational structure and position within the public safety professional community to ensure its standards are unadulterated and reviews of agencies are predicated on objective evaluations of policies, procedures, and practices.

The concept of accreditation allows organizations to voluntarily participate in associated programming to demonstrate compliance with established standards, ranging from operational to administrative duties and responsibilities. The standards also take into consideration the need for progressive and ongoing training, review of tactical and investigatory strategies, the administration of sound and objective-driven hiring and retention practices, and the collection of relevant data for effective decision-making regarding organizational resources and the strategic delivery of services.

Public safety agencies that participate in CALEA® Accreditation are steadfastly focused on the constitutionally anchored administration of services and judicially recognized due process. They use the established

model to promote accountability to their entire service communities, to include victims, witnesses, criminal suspects, and anyone they interact with because of their oaths of office. CALEA® Accredited agencies recognize the importance of perpetual evaluation and apply the concept of continuous improvement as an organizational attribute.

### Some key points from the executive order:

- require federal law enforcement to review and revise policies on use of force
- encourage tightened restrictions on chokeholds and no-knock warrants at the state and local levels
- establish new hiring and data collection guidelines
- restrict transfer of most military equipment to police departments
